- 1.2 The chairperson stated that one of the objectives of this meeting was to explore areas of cooperation especially in academic systems and to build strong relationship between Islamic Higher Education Institutions in Asia. This association is inspired by Bologna Process which has been established by The European Higher Education Area (EHEA) since 1999. The purpose of its establishment is to ensure comparability in the standard and in the quality of higher education systems in Europe.

2. AGREEMENT TO ESTABLISH ASSOCIATION

- 2.1 All members reached a consensus to establish the Asian Islamic Universities Association (AIUA) with the following goals and objectives:
 - i. To create a strategic collaboration in education system between Islamic higher education institutions in Asian.
 - ii. To give a second opportunity to students who are not getting place in public universities by offering them a comprehensive curriculum model.
 - iii. To generate the education fund by using the systems of endowment (waqf fund).
 - iv. To build a wide range of academic standards that can be used as the main guidelines.
 - v. To establish the Asian Islamic Universities Association Foundation that will be funded by waqf.
 - vi. To explore the areas of collaboration between Asian Islamic Universities Association and the industrial organizations.

3. CONFIRMATION OF THE NAME OF THE ASSOCIATION

- 3.1 All members agreed that this association will be named as Asian Islamic Universities Association (AIUA).
